Pursuant to the provisions of Wis. Stat. § 893.80, the Claimant, Geoffrey D.

Wilber, hereby gives formal Notice of Claim and makes a claim for relief in the form of monetary damages, as set forth below:


1. That Geoffrey D. Wilber is an adult individual and resides at 1900 Highland Drive, in the Village of Elm Grove, County of Waukesha, State of Wisconsin.
2. That on February 10, 2023, Ron Hill, while he was in the course of his employment with the Village of Elm Grove Department of Public works, caused personal injury to and interference with the real property of Geoffrey D. Wilber, in violation of Wis. Stat. § 844.01.
3. That pursuant to Wis. Stat. § 839.80, the Village of Elm Grove, the Village of Elm Grove Department of Public Works, and Mr. Ron Hill were all served with a Notice of Injury on or about February 15, 2023.

4. That as a result of the aforementioned incident and negligence, the Claimant, Geoffrey D. Wilber, has suffered permanent and unlawful damage to his real property and seeks recovery for those losses.

WHEREFORE, pursuant to § 893.80, Wis. Stats. Geoffrey D. Wilber demands payment in the amount of \$50,000.00 from said Village of Elm Grove, the Village of Elm Grove Department of Public Works and Mr. Ron Hill.
