President Palmer was asked to give a brief statement on where the Village and Developer are in the process of the School Sisters development project. President Palmer did a basic overview of the last year. All information can be found on our website under Government>Agendas and Minutes. Check Public Works, Building Board, and Plan Commission for the most recent information.

Susan Hanson – 13935 Wrayburn Road – asked what the additional population supported by the project would be. The Village Board took the numbers from Mandel's presentation which included outside data, and took into account the average number of sister on the site over the years - the net is approximately 300 additional people.

John Horter – 13335 Watertown Plank Road – asked what the agenda looked like for the rest of the night. President Palmer briefly went over the agenda.

Christine Krause – 14660 Hillside Road – had a question on apartments. Can they be converted to condos? The answer was they could be, but will likely not be. This was discussed in the beginning asking Mandel to make them condos. The short answer is that the market for condos is weak. The financial risk for this is too high for a developer.

John Geder – 1655 Notre Dame Blvd – this discussion seems premature unless you change zoning. What happened to the lawsuit? Is the change of zoning for this project only? President Palmer indicated the applicant filed the project under existing zoning laws. This does not open up any additional items as it is under the existing laws.

Phil Hawkins – 940 San Jose Drive– does the Mandel group own the property now? President Palmer indicated they do not currently own the property. There is a contract contingent on the project being approved. He continued asking if the village has thought about buying it. There has not been any discussion on the Village buying the property. This would be a significant expenditure.

Dawn Balcom – 15205 Gebhardt Road – asked why it is called a luxury project. The PowerPoint square footage for a three bedroom is 1500 sqft. This doesn't seem like luxury to her. The number of apartments should be smaller and the square footage be bigger. President Palmer asked to bring that specific comment to the plan commission meeting. She also asked about the senior living. President Palmer indicated that Mandel responded to the citizen comments about this and scrapped it.

Tom Castile – 1865 Hollyhock Lane - He believes the citizens are not being listened to. President Palmer and Trustee Domaszek went over the meetings and other items that have been held to share information with the public. They have held separate sessions, met individually with the public, taken phone calls, visited the site, and even met residents out to talk about the project. All of the information is located on our website, you can sign up for notifications when new items arise, and can call the Trustees or President any time there is a question. President Palmer asked what other information they are looking for. It is all out there. Transparency is not an issue if it is all available.

Mary Inden – 14745 Watertown Plank Road. – The Elm Grove Business Association has their Shred Day September 18th from 9am to noon. No metal, bullets, dishes, pots and pans, no newspapers. Old office things. Located in the Park and Shop. Access will be off of Wall St. behind the 890 building. Do not dump and leave. You can watch the shredding. Wanted to talk about the recreation committee. Wants a volunteer chair for the 4th of July. Referenced the photos from the pool house.
