



# SPECIAL ALCOHOL PERMIT

FOR THE CONSUMPTION AND DISPENSING OF CERTAIN ALCOHOL BEVERAGES  
ON SPECIFIC PUBLIC PROPERTY WITHIN THE VILLAGE OF ELM GROVE

IN CONSIDERATION for \_\_\_\_\_ being permitted to consume and dispense without charge fermented malt beverages, wine coolers, and/or wine, as those beverages are defined by law, for the time period set forth on this permit at the location designated therein, the Undersigned, for each and every member of their group or organization, themselves and personal representatives, assigns, heirs and next of kin, and any third persons, represents that he/she has, or will prior to the inception of the activity for which said permit is requested, inspect such public property, and he/she does further warrant that their participation in the scheduled activity and their entrance upon the public property constitutes an acknowledgment that he/she has inspected said Public Property and that it is safe and reasonably suited for the purposes of the Picnic/Pool activity; and that the Undersigned:

- A. HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE the Village of Elm Grove, its Officers, Agents, or Employees from any and all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of the Village of Elm Grove, its Officers, Agents, or Employees, or otherwise while the Undersigned is upon the Public Property; and
- B. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Village of Elm Grove, its Officers, Agents, and Employees and each of them from any loss, liability, damage or cost that may be incurred by any and all persons or property due to the consumption and/or dispensing of fermented malt beverages, wine coolers, and/or wine on or about the Public Property designated and whether caused by the negligence of the Village of Elm Grove, its Officers, Agents, Employees, or otherwise.

Each of the undersigned expressly agrees that the forgoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Wisconsin and that if any portion thereof is held invalid, it is expressly agreed that the balance of this Agreement shall continue in legal force and effect.

Each of the Undersigned warrants the following statements are true and correct and understands that the Village of Elm Grove, its Officers, Agents, and Employees have relied on them in entering into this Agreement and any subsequent granting of a Special Permit under Chapter 171.4 of the Elm Grove Code of Ordinances;

- 1. No oral representations, statements or inducements apart from the foregoing written Agreement have been made.
- 2. The undersigned assumes full responsibility and risk of bodily injury, death or property damage suffered by themselves and any and all third persons due to the negligence of the Village of Elm Grove, its Officers, Agents, or Employees.
- 3. The undersigned warrants and represents that no alcohol beverages of any kind will be consumed by, or dispensed to, persons other than those legally permitted to consume alcohol beverages.
- 4. He/she has read and voluntarily signs this Release and Waiver of All liability and indemnity agreement.
